Just a reminder, when placing your order for W2s and 1099s, remember to order your W3 (Transmittal of Income) and your 1096 (Annual Summary). ***We will begin shipping all tax form orders at the beginning of December. It is your responsibility for checking the contents of your shipment upon receipt of merchandise.***

If you ordered from us last year, we have listed the item(s) you ordered below. If you are ordering the **EXACT STYLE** and **QUANTITY** as last year, just **complete the upper portion on the reverse side and fax the order to us**. If you need to make any changes, or you are ordering for the first time, please complete the **ENTIRE** form on the reverse side.

Your prompt response by **October 16, 2017** will ensure that we meet your Tax form needs in a timely fashion.
